

Participation Agreement and Waiver of Liability

Please read the retreat agreement and sign.

In consideration of participating in the 2022 Treasured Tribe Retreat (“Retreat”), by signing below, I hereby acknowledge that I am of legal age to consent to this agreement and that as part of my participation I assume all risks associated with the Retreat and hereby release and forever discharge Treasured Ministries International Incorporated, its administrators, legal representatives and assigns from all causes of action of and relating to attending and participating in the Retreat to include the injury or even death of the participant.

General Liability Release: The information provided to me during this retreat is for educational purposes only and does not constitute or substitute for professional care or medical advice. I release Treasured Ministries from any guarantees whatsoever. In consideration for the opportunity to participate in the Treasured Tribe Retreat, I acknowledge and accept the risks of injury or illness associated with participation in and transportation to and from the activities during the retreat and the retreat itself. I accept personal financial responsibility for any injury or illness sustained during the retreat or during transportation to and from the retreat. Further, I promise to indemnify, defend, and hold harmless The Cove and Treasured Ministries International or its agents, employees, volunteers, or any other representatives (collectively referred to hereinafter as the “Sponsor”) for any injury-related directly or indirectly out of the Treasured Tribe Retreat or transportation to and from the retreat, whether such injury arises out of the negligence of the Sponsor or otherwise.

- **Cancellation Policy:** If you need to cancel your retreat attendance, Treasured Ministries is unable to guarantee a refund unless we are able to fill your spot. If we can fill your spot, you will receive a complete refund for your registration fee.

If any provision of this Agreement is held to be illegal, invalid, or unenforceable under any present or future law, then that provision will be fully severable. This Agreement will be construed and enforced as if the illegal, invalid, or unenforceable provision had never comprised a part of this Agreement, and the remaining provisions of this Agreement will remain in full force and effect.

This agreement shall be governed by and construed in accordance with the laws of the State of North Carolina.

This agreement contains the entire agreement and understanding between the parties with respect to the Retreat and shall supersede all prior agreements and understandings, oral or written, with respect to such matters.
